## 1. Introduction

To align with its vision, mission, and objective of maintaining high standards of education, UIT University (UITU) is dedicated to enrolling students into various programs through a transparent and well elaborated method of identifying and selecting eligible candidates. The objective of this policy is to maintain high standards of education and ensure fair and transparent admission processes. This policy aims to provide comprehensive details and establish clear procedures for admission to UITU. This policy ensures that the admission process at UITU is conducted in a fair, transparent, and systematic manner, upholding the university's commitment to excellence in education.

## 2. Title

This policy will be called **Admission Policy 2024-25**.

## 3. Definitions

- (a) **'Academic Council'** means the Academic Council of the University;
- (b) **'Admission Committee'** means the forum of University's officials formed under this policy and notified to look after the matter of admissions in line with the scope defined;
- (c) **'Admission Department'** means the office or section managing the affairs of admission.
- (d) **'Admission Policy'** means the title document mentioned in serial 2 above and carries rules, policy and procedure for admission to different program of the University;
- (e) **'Admission'** means the confirmation of admission after fulfilling all eligibility requirement mentioned in this policy.
- (f) **'Admit Card'** means a document ensuring the initiation application has been submitted on the portal and allowing the applicant to appear in UAET;
- (g) **'Associate'** means 2-year program offered after Intermediate or equivalent level;
- (h) **'Authority'** means any of the authorities of the University as specified in Section 7;
- (i) **'Board'** means the Board of Governors of the University;
- (j) **'Chairperson'** means the Chairperson of the Board;
- (k) **'Chancellor'** means the Chancellor of the University;
- (l) **'Commission'** means the Higher Education Commission, Islamabad;
- (m) **'Dean'** means the Head of a Faculty;
- (n) **'Director Admission'** means an Officer appointed as per Section 8 of the Act or the any other officer heading the charge of admission department;
- (o) **'Educational Institution'** means a university or higher educational institution (HEI) recognized by HEC / SHEC;
- (p) **'Eligibility requirement'** means meeting all conditions for admission including pre-qualification eligibility, UAET, interview, qualifying on the merit and paying required fee;
- (q) **'Faculty'** means the Faculty of the University;
- (r) **'Foundation'** means the Usman Memorial Foundation, established under the Societies Act of 1860, with registration number 3848;
- (s) **'Government'** means the Federal or Provincial Government;
- (t) **'Government'** means the Government of Sindh;
- (u) **'Graduate'** means a master's program offered after 16-year or equivalent level of education;
- (v) **'Head'** means Head of a Teaching Department;
- (w) **'Officer'** means any of the officers of the University specified in Section 8 of the Act;
- (x) **'Official'** means a paid employee of the university either fall in the category of faculty member or staff including Vice Chancellor, Dean, Chairperson, Head and Officers.
- (y) **'Patron'** means the Patron of the University;

- (z) **'prescribed'** means prescribed by statutes, regulations or rules;
- (aa) **'Prospectus'** means a booklet contains information, policy, rules and regulations of the University directly or indirectly related to applicant and admitted student;
- (bb) **'Provisional admission'** means the permission to commence academic session and / or to attend classes unless all the eligibility requirements for admission are met;
- (cc) **'Provost'** means the Provost of the University;
- (dd) **'Registrar'** means the Registrar of the University;
- (ee) **'Regulatory authority'** means a body or organization or council entrusted by the Government of Pakistan and / or Government of Sindh for accreditation and / or regulation of University's one or more programs fall into its area of domain;
- (ff) **'Statutes, regulations and rules'** means respectively the statutes, regulations and rules made under this Act;
- (gg) **'Teacher'** means the Professor, Associate Professor, Assistant Professor and Lecturer engaged by the University and such persons as may be declared to be teacher by regulations;
- (hh) **'Teaching Department'** means a Teaching Department established and maintained or recognized by the University;
- (ii) **'Undergraduate'** means 4-year or 5-year program offered after Intermediate or equivalent level;
- (jj) **'University'** means the UIT University;
- (kk) **'Vice Chancellor'** means the Vice Chancellor of the University;

#### 4. Admission to Open for All

Keeping in view the vision and mission of UITU, the admissions are open to all purely on merit basis irrespective of religion, nationality, culture, community, gender, caste, creed, race, colour or domicile. The University is open to all applicants who fulfill eligibility requirement for admission to the programs of study offered by the University. The foreign nationals are also eligible to apply subject if there is no embargo enforced by the Government.

The merit for admission in the University is determined through previous academic achievements, UIT University Admission Entry Test (UAET), interview and seats allocated by the regulatory authority. There are no special quotas, reserved seats or admission by donations nor any arbitrary age limit for the applicants although preference is given to recent qualified students.

It may be noted that the acceptance of admission form and / or appearance in the UAET and / or interview do not guarantee admission, which is made on the basis of merit and availability of seats.

#### 5. Admission Policy

The Admission Policy is part of the Prospectus and duly approved by the Academic Council (AC) every year before its formal implementation. This policy provides admission rules for the batches inducted in the academic year 2024-25 i.e., Fall 2024 and Spring 2025.

The policy is in line with the requirements and guidelines of the Commission and regulatory authorities including relevant accreditation councils. This policy applies to all associate, undergraduate and graduate degree program applicants desirous to seek admission in different programs offered by the University.

The policy is publicized through website and other sources of information for applicant, student, faculty member, staff, parents and others concerned, all of whom are held responsible for reading and adhering to these rules, policies and procedures.

## 6. Grant of Admission

Admission to the associate, undergraduate and graduate degree programs is decided on the basis of the applicant's previous education, eligibility to applied program, passing University Admission Entry Test (UAET), qualifying the interview, fulfill the merit criteria, paying prescribed fee, verification of previous education credentials and meeting all other prescribed requirements either part of this policy or the Prospectus communicated through email or other mode of communication to the applicant.

#### 7.4. Condition for Commencement of Programs

- 7.4.1. The publicity and opening admission in a program does not guaranteed the commencement of program / classes. The public announcement for opening of admission in some cases limited to assessing the response of the market and interest of prospective students.
- 7.4.2. The commencement of classes in any program depends on the minimum number of admission making the program administratively and financially feasible to launch.
- 7.4.3. The programs on serial 7.1, 7.2.2.3, 7.2.2.4, 7.2.3.2, 7.2.3.3, and 7.3 will be offered subject to receiving concurrence from HEC.
- 7.4.4. The University reserves the right to postpone or defer launching of program and commencement of classes in a specific semester.
- 7.4.5. In case a program has not been commenced, the application fee will not be refunded.

### Other Eligibility Conditions

- (a) All pre-requisite qualification shall be from authorized board or equivalent authority / institution of Pakistan
- (b) Awaiting result applicant based on the results of Intermediate / HSSC Part I and appearance in Part II or equivalent examination is eligible to apply for associate and undergraduate programs.
- (c) Applicant with Physics, Chemistry and Mathematics at Intermediate or equivalent level is eligible for all Programs.
- (d) Applicant without Mathematics at Intermediate or equivalent level is required to complete the requirement as follows:
  - (i) pass this deficiency course of 6 credit hours within one-year of regular studies offered by UITU for admission in computer science programs (Ref **Annexure F**: Serial 3.2.4.1 (b) of NCEAC Manual 2023 and NCEAC/HEC/General/3-20, dated March 20, 2020)
  - (ii) conduction of 8-week condensed program prior to become eligible for admission in engineering programs, however, they may be given provisional admission for foundation courses to become eligible for admission (Ref **Annexure E**: PEC/EAD/49-GB/004/2024 dated July 11, 2024)
- (e) Applicant without Chemistry at Intermediate or equivalent level is required to pass this as remedial subject/ course in the 1st Semester after admission for admission in engineering programs (Notification Ref **Annexure B**: PEC/EAD/004/ /2023 dated August 1, 2023 and PEC/EAD/46-VCCM/Edu. Policy/2023 dated March 30, 2023).
- (f) Eligibility marks are with or without grace marks if mentioned on the transcripts by the respective board subject to undertaking from parents (Ref **Annexure D**: Clause 4c, Agenda Item No. 10 of 77th EA&QEC/EAB meeting).
- (g) Admission to Intermediate (Pre-Medical) applicants, if qualify all UITU admission requirement, shall not exceed 40% of total seats allocated to any engineering program (Ref **Annexure E**: PEC 74th EA&QEC/EAB Meeting held on November 18-19, 2015).
- (h) Applicants coming with the background qualification of Diploma in Associate Engineer (DAE) can be considered for PEC approved undergraduate program (Ref **Annexure G**: 106th EAB Meeting dated May 12, 2022).
- (i) All applicants have to provide proof of achieving basic eligibility as per the mentioned criteria for each program as soon as the result of HSSC Part II or equivalent is announced and / or within the specified time period.
- (j) All applicants are advised to carefully read the above eligibility criteria before applying for an admission. The candidates are responsible for fulfilling eligibility and must immediately contact the Admission Department if they are rendered ineligible upon declaration of results.

## 11. Application Procedure

### 11.1. Introduction

Admissions are managed by the Admissions Office during the duration of admission under the supervision of the Director / Head Admission. The advertisements are placed in print and social media. The application of admission is processed remotely online, however, if an applicant would like to use Campus computer lab facility then the same can be provided on request. The tentative application procedure is as below:

- 11.1.1. Register at University's admission portal i.e., "Apply Online" tab on [www.uitu.edu.pk](http://www.uitu.edu.pk)
- 11.1.2. Complete your application and upload required documents.
- 11.1.3. Submit an application and pay the admission-processing fee.
- 11.1.4. Print the admit card from the admission portal.
- 11.1.5. Appear in the UAET at designated test center.
- 11.1.6. Check results & merit list on website and / or email and proceed as per given instructions.

### 11.2. Important Points to Remember

The application will be rejected in case the candidate is found guilty of any suppression or misrepresentation of material facts. At any stage, it is found that the documents on the basis of which admission was granted are forged/ tempered, the admission will be canceled and the fee paid shall be forfeited. The candidate will not be considered for admission in future. The University reserves the right for legal action also.

### 11.3. Overseas Applicants

Overseas applicants may apply in line with above-mentioned guidelines for UAET.

## 12. UITU Admission Entry Test (UAET)

### 12.1. Introduction

The appearance in UAET is mandatory for admission in associate, undergraduate and graduate degree programs. The standard of test for admission in associate and undergraduate degree programs is of Intermediate (HSSC level) whereas for graduate degree program, it is of undergraduate level. The passing of UAET as per University's set threshold is necessary for onward processing of admission application. On qualifying UAET, the applicant become eligible for interview followed by becoming part of department's merit calculation. The test is conducted online in the computer lab(s) at the Campus whereas the eligible applicants are required to physically visit the campus.

The UAET comprises of multiple-choice questions based on the Pakistan's intermediate level for associate and undergraduate degree programs and relevant undergraduate level for the graduate programs. The mandatory portion of the admission test will consist of Mathematics, English, Analytical and General Knowledge.

An applicant who has successfully filled-in application for admission and paid prescribed test fee is eligible for UAET. The passing the test is not the guarantee of admission and / or provisional admission.

A former student of the University whose enrollment was canceled due to unsatisfactory academic performance may also reappear in the admission test. If selected, she/he will be enrolled in the first semester as a fresh student.

- 12.3.1.4. General Knowledge (10% - 10 Questions)

#### 12.3.2. Graduate Programs

The UAET of graduate degree programs contain following subject:

- 12.3.2.1. General Mathematics (10% - 10 Questions)
- 12.3.2.2. English (15% - 15 Questions)
- 12.3.2.3. Analytical (10% - 10 Questions)
- 12.3.2.4. General Knowledge (10% - 10 Questions)
- 12.3.2.5. Subject Area (55% - 55 Questions)

### 12.4. UAET Structure

#### 12.4.1. Time

The maximum time allowed to answer all questions in a section is displayed in the test portal on the Instructions page. This time is also displayed on every page of the test so that the candidates can pace themselves according to the time left for that section.

#### 12.4.2. Number of Questions

A section has a specified number of questions. This number is displayed in the test portal and also on every page of the test.

#### 12.4.3. Weight of a question

All questions carry equal marks which is used to calculate the candidate's score in that section.

#### 12.4.4. Negative Marking

There is no negative marking.

#### 12.4.5. Passing Criteria

The passing threshold is set by the Admission Committee based on overall outcome of UAET. The passing criteria for applicants for engineering programs accredited by HEC is in line with attached **Annexure A** (Ref: PEC/EAD/004/2023 dated August 1, 2023)

### 12.5. Alternate Admission Test

As mentioned in serial 12.2 above, there are various tests that can substitute or used as replacement of UAET, nevertheless, it has to be timely informed before the date of UAET. In line with PEC guidelines attached as **Annexure C** (Ref: PEC/EAD/46-VCCM/Edu.Policy/2023 dated March 30, 2023), the admission test for applicants for engineering programs may also be conducted at other university or educational institution.

### 12.6. Exceptions

Any exception to the above mentioned UAET criteria may be considered / approved by the Admission Committee on a case to case basis. However, such relaxations / exceptions do not overrule the regulator's requirements and / or statutory bodies' rules.

## 13. UITU Admission Interview (UAI)

All applicants are required to pass UAI. The interview assesses applicant's interest, seriousness, physical fitness, communication skills, dedication level and commitment to financial affordability towards applied program. The UAI also assesses the reasons for preferring the University's program over programs of other universities. The interviews are conducted by learned panel of faculty members and / or senior officials.

## 14. Merit Determination Criteria

### 14.1. Merit Setting

All applicants who qualify the UAET and UAI are evaluated on the basis of following for merit determination:

#### 14.1.1. Undergraduate / Associate Degree Programs

In case of not having any result of HSC Part II or equivalent examination, the results of HSC Part I or equivalent examination will be considered in serial 13.1.1 (2) and in case of not having any result of both HSC Part I and II or equivalent examination, then only serial 13.1.1 (1) and 13.1.1 (3) will be considered on pro-rata basis for determining merit criteria.

#### 14.1.2. Graduate Programs

#### 14.2. Hafiz-e-Quran

Additional 20 marks are added in the marks obtained by the applicant in HSSC or equivalent Examination on the basis of Hafiz-e-Quran subject to production of original *Sanad* from Wifaq-ul-Madaris Arabia Pakistan or equivalent wifaq and University's assessment. This addition will be considered for determining merit of the candidate and will not affect the eligibility condition for accepting of admission form.

#### 14.3. Tie Resolution

In case of tie for merit position in the selection for admission, the aggregate marks obtained in UAET shall be the criteria for resolving the tie.

#### 14.4. Waiting List

If an applicant does not qualify for the merit list of any program, then his / her name will be placed on the waiting list. Such applicant will be informed / intimated through a letter or email about waiting status along with other program options (subject to availability of seats) which he / she may opt in writing.

#### 14.5. Applicant to Candidate

Once an applicant has received admission offer, his status would be changed to a candidate.

### 15. Provisional Admission Offer

#### 15.1. Allotment of Program

The allotment of programs of a department is made strictly on merit basis and in order of choices given by candidates on their admission applications. However, a candidate may be offered admission in a different faculty/program of his/her choice if vacant seats are available or created by non-acceptance of admission offers by other candidates.

#### 15.2. Admission Offer

Once a name of the candidate has appeared in the merit list, he / she is being offered admission in any one program of the University through a formal letter or email or SMS. On receiving the offer, candidate is required to submit following documents and submit fees within specified duration or extended (if any) otherwise University reserves the right to cancel admission offer:

- 15.2.1.1. System Generated Admit card of UAET (Printed)
- 15.2.1.2. Photocopy of SSC or equivalent examination marks sheet
- 15.2.1.3. Photocopy of SSC or equivalent certificate
- 15.2.1.4. Photocopy of HSSC or equivalent examination marks sheet
- 15.2.1.5. Equivalence Certificate from IBCC for Foreign Examination, if applicable
- 15.2.1.6. Declaration of non-participation in political activities and no indulgence in unwanted activities on Judicial Stamp Paper of PKR 100

- 15.2.1.7. Six Passport Size Photographs (with Blue / White Background)
- 15.2.1.8. Photocopy of student, guardian or father and mother's CNIC
- 15.2.1.9. Undertaking by the candidate's father/guardian to abide by the rules and regulations
- 15.2.1.10. Hafiz-e-Quran *Sanad* if applicable Original from Wifaq-ul-Madaris Arabia Pakistan
- 15.2.1.11. Original HSSC marks sheet after announcement of Intermediate Part II or equivalent result

#### 15.2.2. Graduate Programs

- 15.2.2.1. System Generated Admit card of UAET (Printed)
- 15.2.2.2. Photocopy of last degree / transcript
- 15.2.2.3. Photocopy of SSC or equivalent examination marks sheet
- 15.2.2.4. Photocopy of SSC or equivalent certificate
- 15.2.2.5. Photocopy of HSSC or equivalent examination marks sheet
- 15.2.2.6. Equivalence of international degree from HEC is mandatory, if applicable
- 15.2.2.7. Declaration of non-participation in political activities and no indulgence in unwanted activities on Judicial Stamp Paper of PKR 100
- 15.2.2.8. Six Passport Size Photographs (with Blue / White Background)
- 15.2.2.9. Photocopy of student and father's CNIC
- 15.2.2.10. Proof of experience certificate in case any qualification requires work experience
- 15.2.2.11. Undertaking by the candidate's father/guardian to abide by the rules and regulations

Note: Generally, after admission offer email, three days are given to submit full fee and reserved the seat. If a candidate fails to pay fee within the specified time, then his / her admission will be cancelled and the seat will be offered to the next candidate in the merit list. Confirmation of all provisional admission will be subject to payment of tuition fee and other dues by the deadline mentioned in the offer letter and submission of medical certificate of fitness (if required). It may be noted that rules and regulations are subject to change from time to time.

#### 15.3. Retaining Original Document

Original degree / marks sheet of last / eligibility examination will be retained by the University and the same will be returned after the completion or termination of the studies at the University. The applicants are cautioned that in their own interest they should retain sufficient number of attested photocopies of their documents/certificates as the originals are not likely to be returned during their period of study at the University. However, the Photostat of the required documents can be provided to the students on submission of application on the prescribed form on payment of Rs.50/- each of documents on the notice of seven working days, subject to availability of the documents. • The admission of applicant, who does not submit the original documents on the specified scheduled date, may be cancelled.

#### 15.4. Undertaking / Affidavit

The applicants are required to submit undertakings / affidavits / forms applicable through this policy before admission.

## **16. Conversion of Provisional to Regular Admission**

Provisional admission will be offered to all candidates who qualify as per merit. A candidate will however, be required to submit their HSSC Mark Sheet with having minimum marks as per eligibility criteria (refer to serial 15 above) otherwise, their admission will be cancelled. Similarly, for A-Level candidate along with their transcript or IBCC equivalency certificate with minimum equivalent marks as per eligibility criteria to be submitted soon after announcement of their respective results or by the time given by the University.

As per general guideline, we expect candidate to submit HSSC or equivalent completion certificate immediately after announcement of results or maximum by specified deadline date announced by the University. By any mean, completion certificate of HSSC or equivalent shall be submitted before commencement of final examination of the first semester. In case of non-submission or having secured lesser than eligibility marks, the admission will be cancelled.

Once the HSSC Part II or equivalent certificate will be received then the same shall be sent to respective board or institution for verification, the student may become eligible for the conversion of provisional to regular admission.

## **17. Enrollment**

On confirmation of admission, each student is required to fill in an enrollment form available at the Registrar's Office. Each enrollment form must be filled, signed, and submitted in person or through portal by the student. Any form electronically submitted must be signed by the applicant before any further processing. Each enrollment form must be endorsed / attested by a magistrate of the first class officer or any officer of the University.

## **18. Option in case of Ineligibility of Confirmation of Admission**

In case an applicant is unable to fulfill eligibility requirement for confirmation of admission and his / her fees cannot be refunded as per rules, then such applicant may be allowed to complete the semester in which he / she is provisionally admitted. Such course(s) will not be graded and on successful completion and recommendations from Academic Operations Department, the applicant will be provided participation certificate from the University's Centre for Continuing Education (CCE).

## **19. Rejection of Application**

The University reserves the right to reject any application or cancel / withdraw any admission of a student.

## **20. Change of Program / Discipline**

The change of program / discipline after confirming admission in one program is not allowed. However, student may be considered for change of program / discipline if there is a vacant seat (due to cancellation) after completion of the regular admission cycle. The offer of new program depends on the student's standing on the merit.

A student interested to change the program / discipline will be required to submit application specifying the reason along with the withdrawal of admission in the current program. In such cases, the submitted admission fee and semester charges will be forfeited whereas tuition fee will be transferable subject to not exceeding half duration (8 weeks) of the semester.



## **21. Duration of Program**

The duration of all undergraduate courses of studies leading to the degree of BE, BS, BBA and B.E. Tech shall be of minimum four (04) academic year. Any student who fails to complete all requirements for his/her degree in the prescribed time may continue study for further three academic years. Consequently, maximum seven academic years shall be allowed for each 4-year degree program. In case of extending the period beyond regular batch and / or four years, the left over courses will be offered with previous batches and the University will not be liable to offer a course exclusively for the student.

The maximum duration of associate and graduate degree programs are in line with guidelines of HEC and / or regulatory authority.

## **22. Medium of Instruction**

Instructions in all courses and laboratories are carried out in English Language. The examinations are also conducted in English.

## **23. Employment / Dual Enrolment**

All undergraduate degree programs (except Technology Programs) are regular and full-time day programs. No student admitted in this University shall be allowed to engage himself / herself in employment. Similarly, no student is allowed to simultaneously register in the associate or undergraduate degree program or courses of studies in any other university or educational institution. The violation of above may lead to cancellation of admission.

## **24. Cancellation of Admission / Registration / Enrolment**

- (a) In case at any stage it is found that the documents on the basis of which admission was granted are forged / tampered / bogus, the admission of the student will be cancelled and the fee paid shall be forfeited. University also reserves the right for legal action. However, he / she may file appeals against such decision with the Vice Chancellor within 15 days from the date of notification / intimation along with a fee of Rs.500/-
- (b) If a student fails to attend classes for four weeks consecutively in a regular semester (two weeks in Summer semester), without prior approval, his/her admission may be suspended. However, he/she may be allowed to continue studies in next semester on the recommendations by the Chairperson / Dean on the payment of prescribed fee.
- (c) Admission of any such student of any year/ semester who has been rusticated from the University on account of breach of any discipline for any specified period shall be cancelled and notified. However, after expiry of the period the student may be allowed re-admission / registration in the same year / semester with junior batch, if otherwise eligible.
- (d) Admission and enrolment of any such student of any year/ semester who has been expelled from the University on account of breach of any discipline shall be cancelled after due process and subsequently notified / intimated. The student shall not be eligible for any subsequent admission in the University.
- (e) The Application shall be rejected in case the candidate is found guilty of any suppression or misrepresentation of material facts. In case at any stage it is found that the documents on the basis of which admission was granted are forged/ tempered, the admission will be cancelled and the fee paid shall be forfeited. The candidate will not be considered for admission in future. The University reserves the right for legal action also.

## 25. Fee Structure

The fee structure varies in each semester subject to the inflation and approval of the competent authority with the sole objective to meet the expenses of quality education. The fee is comprised of following components:

### 25.1. Application Fee

The application fee is charged once at the time of applying for any offered program at the University. It generally covers the cost of pre-application activity, UAET and UAI. It is mandatory to pay before issuance of admit card and appearing in UAET. Once the admit card has been issued, the application fee will not be refunded regardless of applicant's appearance in the UAET.

### 25.2. Admission Fee

The admission fee is charged once at the time of getting provisional admission. It generally covers the cost of processing admission. The admission fee is not refundable in case student himself / herself opt to leave the University. In case University does not commence the classes then the admission fee paid is either transferable or refunded on request.

### 25.3. Enrolment / Document Verification Fee

The enrolment is charged once at the time of getting admission. It generally covers the cost of verification of student previous academic record. The enrolment fee is not refundable in case student himself / herself opt to leave the University. In case University does not commence the classes then the admission fee paid is either transferable or refunded on request.

### 25.4. Security Deposit

The security fee is charged once at the time of getting admission. It generally covers the risk of non-payment of fee and financial liability in case of adverse behavior of student during the period of stay at the University. The security deposit is refundable at the time of leaving the University and / or cancellation of admission subject to submission of prescribed clearance form and deduction of outstanding dues, If any.

### 25.5. Semester Charges

The semester fee is charged every semester. In line with HEC guidelines, the university and educational institution will have to provide uninterrupted power and internet connectivity to students within and outside the class. These charges include various non-academic expenses for facilitating student to adequately fulfill academic requirements. It generally includes uninterrupted electricity, internet lab charges, internet connectivity, printing cost, etc.

### 25.6. Co-curricular Activity

The co-curricular activity fee is charged every semester. In line with HEC guidelines, the university and educational institution will have to provide necessary facilities for co-curricular activities so as to ensure wholesome development of student. These charges include cost of sports equipment and facilities, student society programs, etc.

### 25.7. Examination Fee

The semester fee is charged every semester based on number of courses registered. These charges include various expenses related to conduct of examination including development and printing of papers, invigilation, evaluation, etc.

#### 25.8. Tuition Fee

The tuition fee is charged every semester based on number of credit hours opted by a student. This covers the cost of quality teaching, faculty member, support staff, classroom, teaching aid, etc.

#### 25.9. Fee Installment

The installment of fee in the first semester is only available for few programs subject to approval of the competent authority with the addition of financial cost for defer payment.

For program wise details fee, kindly visit the website or contact Admission Department. The fee is refunded in line with HEC's fee refund policy.

## 26. Admissions Committee (Adcom)

#### 26.1. Purpose

The purpose of this Adcom is to select meritorious and outstanding applicants for admission at UIT University. The committee will make sure that the selection of individual student for admission in a program should not be influenced by any political or financial factors. The Committee's authority originates by delegated powers from the competent authority of the University i.e., Academic Council.

#### 26.2. Role / Scope

The Adcom is an oversight and decision making entity. The major responsibility of the committee is to identify and select applicants who demonstrate the ability to fulfill the purpose of the associate, undergraduate and graduate degree programs at the University. The committee ensures the admission process is applied equally and consistently to all applicants. The committee reviews all applicants in terms of their potential academic success in offered programs. The committee's role is as follows:

- 26.2.1. Monitor compliance with University policies and procedures related to student admission.
- 26.2.2. Review and recommend policies, requirements and procedures for admission to the Academic Council;
- 26.2.3. Evaluate and set the various tools, criteria and procedures used in the process of selection from the pool of applicants;
- 26.2.4. Receive and act on reports on external benchmarking related to admissions, including pre-admission entry test (or equivalent) thresholds;
- 26.2.5. Evaluate the qualification of applicant and determine final selection as per the approved admission policy;
- 26.2.6. Coordinate and guide the faculty members who serve as interviewers of prospective students; receive and evaluate interview reports and recommendations of interviewers as a source of information on the suitability of prospective candidates;
- 26.2.7. Receive and act on biannual reports on admissions data from Admission Department;
- 26.2.8. Advise on other matters referred to the Committee by the Vice Chancellor and / or Academic Council;
- 26.2.9. Where relevant, refer matters to the Academic Council;
- 26.2.10. Consider and dispose appeals related to admissions.

### 26.3. Membership of the Admissions Committee

The Adcom shall comprised of University's official. During the meetings of Adcom, any other person can be invited on special invitation with the consent of the Convener to add value to the proceedings of the committee. The Chair has multiple duties that include moderating the Adcom meetings. The Convener is a non-voting member unless there is a tie and can cast his tie breaking vote (if needed). A simple majority vote is necessary to approve any motion reviewed by the Admissions Committee. The Admission Committee has the final authority to decide on the matters of admission, subject to the condition it does not overrule decisions of other statutory bodies of the University and rules prescribed by the Commission and the regulatory authority. The Convener in consultation with the Vice Chancellor may add or remove a member at any time at his/her discretion.

The committee membership is as follows:

- 26.3.1. Provost, Convener and Head of Committee
- 26.3.2. All Deans, Member
- 26.3.3. All Chairpersons, Member (departments which offered programs)
- 26.3.4. Registrar, Member
- 26.3.5. Director Admission, Member
- 26.3.6. Officer Admission, Secretary

For serial 26.3.2 and 26.3.3 above, Dean and Chairperson may nominate someone on their behalf if in case they are unable to attend the meetings of the Committee. For Serial 25.3.6, Director Admission will nominate any officer of the Admission Department.

The Adcom will regularly meet during the period admissions and as and when required by the Convener or requested by the Director Admission or any other member of the committee. The agenda, date, time and location of meeting will be determined by the Convener whereas notice of meeting and agenda will be circulated by the Secretary.

### 26.4. Quorum

Among the Convener and members, 50 % presence will constitute the quorum of the meeting.

## 27. Superseding Laws / Rules

All laws of the land or policies and rules enacted and / or notified by the Government, Commission and / or regulatory authority including Sindh Higher Education Commission (SHEC), Charter Inspection Evaluation Committee (CIEC), Pakistan Centre for Philanthropy (PCP), Pakistan Engineering Council (PEC), National Computing Education Accreditation Council (NCEAC), National Business Education Accreditation Council (NBEAC), National Technology Council (NTC), etc will superseded this policy. .

## 28. Amendments in the Policy

The policy is subject to revision as and when required by the competent authority. Any change in the Policy shall initially be discussed in the Admission Committee and accordingly be recommended to the respective BOS and BOF through the Registrar's office for consideration and approval before being put up to the Vice Chancellor and Academic Council. In case of urgency, the Vice Chancellor on the recommendations of the Admission Committee (having presence of all Deans and Chairpersons) may directly send the item to the Academic Council for approval.

*"Framework for entry test relating to admission in Engineering Programs communicated vide PEC letter No.PEC/EAD/46-VCCM/Edu.Policy/2023 dated March 30, 2023 was ratified to remain effective regarding the mechanism to be followed by all HEIs with the exemption to the extent of qualifying marks of 33% in the Entry Test similar to waiver given for last year vide PEC letter No.PEC-EAD/004/ET/2022 dated November 18, 2022.*

*However, it was reiterated that the HEIs may provide multiple chances (at least two) for Entry Test. Further, HEIs in Public and Private Sector having experience and credibility to conduct Entry Test are also allowed after taking NOC from PEC as per the provision mentioned at para 2 (2)(a)(vi) of PEC policy letter issued on March 30, 2023."*

In addition, a combination of Physics, Mathematics and Computer Studies/ Computer Science (ICS) is allowed for admission in all Engineering Programs, with Chemistry as a remedial subject/ course in the 1<sup>st</sup> Semester after admission. A combination of Biology, Physics and Chemistry (Pre-Medical) is also allowed for admission in Bio-Medical or Bio-Engineering."*

**Subject: Policy Decision – Framework for Entry Test Relating Admission to Engineering Programs**

I am directed to state that in light of decision of 44<sup>th</sup> Governing Body (GB) held on October 18, 2022, the 46<sup>th</sup> Vice Chancellors' Committee (VCC) in its meeting held on February 2, 2023 decided the following on the subject matter:

- i. The PEC policy of entry test along with designated entities/ testing agencies would be continued and extended for the upcoming admission in engineering programs.
- ii. Meanwhile, PEC with focus of quality intake in engineering programs would launch Centralized/ Unified Entry Test through transparent bidding process as a parallel option to the students and HEIs to opt as facilitation in addition to the designated/ existing entry test entities.

2. Accordingly, the approved policy regarding entry test for admission to Engineering Programs to be adhered by all HEIs offering engineering programs in Pakistan, as under:

**(1) Open competition among FSc/ A-Level and relevant DAE holders for admission to engineering programs**

- a. To allow admissions to engineering programs through open competition amongst the F.Sc/ A-Level and relevant DAE holders (as per Regulations of Engineering Education) providing a level playing field to ensure quality intake.

**(2) Designated Entity/ Testing Agency to Conduct Entry Test**

- a. The entry test being conducted would be applicable to all HEIs (both public and private) as:
  - i. Entry Test being conducted by UET Lahore
  - ii. Entry Test being conducted by NED-UET, Karachi and MUET, Jamshoro
  - iii. Entry Test being conducted by NUST Islamabad
  - iv. Entry Test being conducted by NTS
  - v. Entry Test being conducted by ETEA
  - vi. Any other existing recognized entity conducting entry test

### (3) Determination of Merit through Entry Test

- Multiple chances (atleast 2 times) for Entry Test be allowed to facilitate maximum students as best result be taken.
- The admissions by all HEIs (both public and private) would only be made based on the result of entry test of the designated Testing HEIs/ entities regardless of provincial/ regional territories. The same lists would also be available through PEC website.
- The passing marks in the Entry Test by designated HEIs/ Entities will be minimum 33%.
- The weightages of Entry Test for merit determination would be minimum 33%.
- The remaining 67% weightage (out of which minimum 50% for FSc/ A-level/ relevant DAE, and rest for matric, interview etc.) would be the prerogative/ domain of concerned HEI subject to have well laid-out and transparent procedure to compute overall merit for admission into an engineering program.

**b) Agenda Item No. 07: Proposed Policy on fulfillment of Legal Requirements for launching an Engineering Program by Affiliated Institute/College and constituent campus**

After deliberation the following policy was decided in light of the HEC and PEC guidelines regarding launching of an engineering program. In future, before conducting a zero visit, the following clearance on the legal status shall be required:-

- i. Recognition / due approval of affiliated institute or constituent college or a sub campus by DAI and HEC (*in case of Federal Territory*) or HED / Chancellor (*in case of Provincial Territory*) having provision of engineering faculty in the act of DAI.
- ii. In case any DAI wants to start an engineering programme and does not have the provision in its act, shall require the engineering faculty be added through a formal approval of HED/HEC/Chancellor [whichever applicable]. For the purpose of documentation, wherever required, the DAI may apply for NOC from PEC. In such cases, the formal application with applicable fee fixed for this purpose, be submitted to Engineering Accreditation Department through registrar PEC. The same shall be placed for the house (EA&QEC/EAB) to approve by checking the relevant provisions of the university / DAI's Act or Charter. This NOC shall not be equivalent to a formal green signal which may be given by PEC after a zero visit and confirm in writing that the DAI may enroll the students in the specified intake limit with effect from a certain intake.
- iii. Affiliated colleges shall be considered for zero visit only if the parent university seeks prior approval from PEC on the specific cases through a prescribed form and fee. Without such written approval, no engineering programme can be started at any affiliated institution / college.
- iv. To start an engineering programme at any institution within Pakistan, the zero visit is mandatory without which the programme shall not be considered for any accreditation. In addition to that, PEC shall not deploy the visitation team for zero visits unless the above legal status is clearly provided.

**c) Agenda Item No. 10: Request for Admission in Engineering Programs on the Aggregate Percentage i.e. 59.73%**

After detailed deliberations, the house decided that PEC has no objection if HEI admits a student with 60% marks (with or without grace marks) mentioned on the transcripts by the respective board. In this particular case, it was observed that the certificate of the Board of Intermediate, Karachi enumerates that the board has added three (3) marks to raise the grade to 'B' which is equal to 60% as mentioned. Therefore, the house unanimously approved and declared him eligible for admission.

Subject: Policy Decision - Amendments in Article 2(a)(i) of PEC Regulations for Engineering Education in Pakistan

It is to inform that PEC Governing Body in its 49<sup>th</sup> meeting held on June 28, 2024, decided to allow the students having HSSC (Pre-Medical) qualification to be considered for admission in all engineering programs as per Article-2(a)(i) of PEC Regulations for Engineering Education in Pakistan. In this regard, the HEIs are advised to adhere the following approved guidelines/ SOPs for admissions of all such students:

- i. Entry Test mechanisms/ regimes be moderated to include above qualification and its weightages for admission eligibility.
- ii. Conduction of 8 weeks condensed program to compensate for deficient courses viz. Mathematics, prior to become eligible for admission in engineering programs. This may be considered as provisional admission for foundation courses to qualify to be eligible for admission through entry test.
- iii. The university conducting 8 weeks program would be responsible to develop condensed program and to ensure quality of Teaching, Learning and Assessment.
- iv. Students will be admitted in accordance with the admission admissibility criteria as per discipline's merit and student preference.
- v. 40% seats within the total allowed intake for each batch of the respective programs may be filled with the background qualification of HSSC (Pre-Medical) for those students who have successfully completed the aforementioned condensed program.
- vi. The university will conduct an entry test for students qualifying the condensed program separately for determining the merit for admission.
- vii. The university admissions cycle may vary in accordance with regional requirements for the commencement of the academic year.
- viii. The requirement of 60% in HSSC is mandatory for admission in engineering programs as per Article 2(a)(i) of PEC Regulations for Engineering Education in Pakistan.

2. The SRO for the amendment in PEC Regulations is under process and will be shared shortly.

each course must be maintained. The labs should be well-equipped with the requisite computing equipment/machines such as basic components, modules, measuring instruments, etc.

#### **3.2.3.4 Design Projects**

Computing relates to the design of solutions. The students of a computing program must be encouraged to undertake design projects as an integral part of every core subject. Such design projects should be geared towards solving complex problems and complex computing activity.

#### **3.2.3.5 Final Year Design Project**

The final-year design project (FYDP) should span over at least two consecutive semesters, that is, semesters 7 and 8, totaling 6 credit hours. It is the capstone of a computing program. Undertaking a final year design project is a compulsory requirement. It should mainly comprise literature search, individual analysis, formulation of a complex problem and its solution through complex computing activity.

The FYDP report shall adhere to the best practices and guidelines of report writing for projects.

#### **3.2.3.6 Internship Program**

The program should facilitate and promote cooperative learning through mandatory supervised internship program of continuous 6-8 weeks duration in a professional computing organization. The training program should be planned and agreed upon by both the institution and the host organization. The institution should receive a report about each trainee indicating the training details, interest shown by the student, his/her work habits and punctuality. Assessment of internship program through defined rubrics encompassing respective learning domains shall be demonstrated.

### **3.2.4 Criterion 4 - Students**

The quality of students admitted, and their academic progression are important considerations in evaluating the success of a program in achieving its objectives.

#### **3.2.4.1 Admission Criteria**

- a At least 50% marks in Intermediate/ DAE with Mathematics as a subject or equivalent 12 years education with Mathematics as a subject are required for admission in all BS/ BSc Computing Programs except BS/ BSc/ BE Computing Engineering.
- b At least 50% marks in Intermediate Pre-medical (subject combination of Physics, Chemistry and Biology) or equivalent 12 years education are also eligible to apply. Such candidates, if admitted, are required to study additional two Mathematics courses, worth 6 credit hours, during first year of studies at the institution.
- c At least 60% marks in Intermediate/ DAE with Physics, Mathematics and Chemistry/ CS or equivalent 12 years education with Physics, Mathematics

and Chemistry/ CS are required for admission in all BS/ BSc / BE Computing Engineering program.

**Note:** The determination of equivalence and issuance of equivalent marks certificate up to HSSC level for certificates other than those issued by Pakistan's Boards is the jurisdiction of the Inter Board Committee of Chairmen (IBCC). The following are the addresses of the IBCC offices:

#### **3.2.4.2 Annual Intake**

This aspect pertains to the number of students admitted considering the capacity of the program and its allied facilities through an assessment process. The program intake should be in line with the standards of NCEAC.

#### **3.2.4.3 Transfer of Students**

The institute shall develop a clear, documented and well publicized policy on the transfer of students from other institutions. The policy shall take into account evaluation of credit equivalence for the subjects studied in an accredited program of a HEC recognized institution and should be based on justifiable grounds. No more than a maximum of 50% of the total credit hours required for the degree program should be transferred. All such cases of student transfer should be intimated to NCEAC for information and record at the time of acceptance by the institution.

#### **3.2.4.4 Academic Counseling**

This aspect pertains to the guidance available to students from teachers through dedicated office hours beyond scheduled timetable. The office hours must be publicized by the instructors by posting them on the office doors/noticeboards. Tutorials, problem-solving and/or help sessions, when planned, should be scheduled, and made a part of the timetable. RAs and TAs / GAs engaged to provide extra coaching and/or subject assistance, especially when assisting the main instructor with a larger class-size, should also maintain specific designated hours for off-class assistance/counseling. Individual students' academic progress should be monitored, and corrective measures taken on a regular basis through well-defined mechanism.

#### **3.2.4.5 Career and Student Wellness Counseling**

In addition to the course specific guidance, the institute should have designated student counselors who would advise and counsel students regarding academic as well as career matters. A formal orientation session for the newly admitted students to apprise them about the salient requirements and policies/procedures of the program is highly desired. The student wellness counselor(s) should also provide assistance to students in managing their health, financial, stress, emotional and spiritual problems.

This aspect pertains to the number of students per section for the theory
