Policy of Resolution Numbering of Regular Meetings

1. Policy Statement

- 1.1. It is the policy of UIT University to document and publish all resolutions passed by statutory bodies, such as the Academic Council, the Board of Faculty, etc. in accordance with the established guidelines for resolution numbering. This policy must be read in conjunction with the Rules of the University. In case of any inconsistencies between this policy and the rules of the university, the rules of the university will take precedence. The Vice Chancellor's decision will be final on the interpretation of any policy provision related to the documentation and numbering of resolutions.

2. The Need

- 2.1. UITU follows a system of numbering resolutions for the Board of Governors (BOG) and Academic Council (AC) meetings. However, no approved policy extends to other meetings presently. While documenting minutes of regular meetings, departments generally assign resolution numbers against an agenda point without giving due consideration to the meeting platform, departmental/faculty ownership, and meeting count. This situation often results in difficulties in subsequent referrals for meeting decisions/resolutions for various purposes.
- 2.2. With the aforementioned in view, an integrated system of numbering the resolutions of agenda points of meetings is being proposed, which should be followed for all regularly scheduled meetings at the University, Faculty, and Department levels. With the proposed scheme, all stakeholders will be able to extract instantly the following information by simply looking at the Resolution No. of a meeting and will also be able to assign a Resolution No. effortlessly:
- a. Meeting platform
 - b. Faculty ownership
 - c. Departmental ownership
 - d. Count of the meeting
 - e. Agenda point reference
 - f. Sub Agenda point reference (if any)

3. Meeting Platforms

4. Proposed Numbering System for Meeting Resolutions

- 4.1. The details of the proposed numbering system for meeting resolutions, including numbering templates and examples, are provided in Appendix A.

5. Implementation and Communication

- 5.1. All Departments and Faculties of the University should adopt the proposed resolution numbering scheme.
- 5.2. The proposed numbering system should be implemented with immediate effect.
- 5.3. This policy shall be communicated to all faculties, departments, and relevant stakeholders for immediate implementation and compliance.
