Fair Academic Standing

Students who maintain a minimum cumulative grade point average (**CGPA**) as per the University's graduation requirement i.e., 2.00 and a fulltime status by enrolling in minimum 12-15 credit hours per semester are considered to be in "Fair Academic Standing".

Good Academic Standing

Students who maintain a minimum CGPA of 3.00 and a fulltime status by enrolling in minimum 12-15 credit hours per semester are considered to be in "Good Academic Standing". Students who do not maintain a good academic standing, will not be eligible for the following:

- University's study abroad program;
- To be on Dean and VC's Honors List of the University (*Conditions apply*)
- Work-Study / Student Employment opportunities; (*Conditions apply*)
- Scholarship and/or Financial-aid. (*Conditions apply*)

Academic Warning

Students will be placed on "Academic Warning" if their CGPA falls below 2.00;
 Students on Academic Warning must meet with their academic advisor to design an Academic Success Plan. If the student achieves a CGPA of 2.00 at the end of the semester, the student shall be restored to "Fair Academic Standing."

First Academic Probation

Students who are already issued an "Academic Warning" will be placed on "First Academic Probation" if they fail to achieve a **CGPA** of 2.00 by the end of the semester in which they were given the "Academic Warning".
 Students on 'First Academic Probation' must meet with their academic advisor to revise the Academic Success Plan.

Final Academic Probation (*This is the 3rd and final warning*)


Students will be placed on "Final Academic Probation" if they fail to achieve a CGPA of 2.00 by the end of the semester in which they were placed under "First Academic Probation".


Students on "Final Academic Probation" will not be allowed to enroll in more than twelve (9) credit hours and in any new course(s) unless their required repeat courses are not available.

They will also undergo any additional intervention plan mandated by the academic advisor and program director/HOD. If the student achieves a CGPA of 2.00 at the end of the semester, the student shall be restored to "Fair Academic Standing".

Academic Dismissal

Students will be expelled from the University if they fail to achieve the CGPA required to maintain "Fair Academic Standing" by the end of their "Final Academic Probation" period. Additionally, students who refuse to follow the mandated course plan during "Final Academic Probation" may also be dismissed from the University. Students dismissed for academic reasons are not eligible for **re-admission** to the University or a **tuition refund**.
